» IN CONVERSATION WITH LAWRENCE WONG *Deputy Prime Minister & Minister for Finance, Singapore*

Singapore's Deputy Prime Minister and Minister for Finance, Lawrence Wong, talked to Rich Karlgaard, Futurist and Editor-at-Large, Forbes Media, on a wide range of issues. He cautioned that the era of deglobalization may be at hand, where "geopolitics is shaping trade and investments." He commented on the U.S.-China relationship, where he sees growing frictions. The deputy prime minister also discussed his vision for Singapore. "Despite these challenging times, we believe that here in Singapore...we can continue to be a bastion for stability, opportunities, and innovation," said Wong. When asked what defines the Singapore brand, he said "It is trust within Singapore and it is also trust with all our partners. We are fortunate in Singapore to be a high trust society. And trust enables many things to get done... Because we trust one another, there is a strong compact, and we work together, and we keep faith with each other. That is what keeps Singapore going."

➤ KEYNOTE ADDRESS BY GAUTAM ADANI *Chairman, Adani Group*

Gautam Adani, Chairman, Adani Group, gave a keynote address that showcased his vision of India's future. "In my view, the global turbulence has accelerated opportunities for India. It has made India one of the few relatively bright spots from a political, geostrategic, and market perspective," Adani said in his address. He expects that India will become one of the world's largest economies. "We will be the country that will go from a 3 trillion-dollar economy to a 30 trillion-dollar economy, a country with a stock market capitalization of 45 trillion dollars, and a country that will be supremely confident of its position in the world," he said. Speaking at the time as the world's second richest man, Adani talked about how he is using his enormous business empire to help develop India's economy, such as improving its infrastructure and energy sectors. "As a group, we will invest over 100 billion dollars of capital in the next decade," he declared.

» FIRESIDE CHAT WITH ERICK THOHIR *Minister of State-Owned Enterprises, Indonesia*

Erick Thohir, Minister of State-Owned Enterprises, Indonesia, spoke to Justin Doebele, Editor and Vice President – Content, Forbes Asia, about his efforts to reform the critical state-owned enterprises sector of the Indonesian economy. These companies under state control contribute about one-third of Indonesia's trillion-dollar-plus economy, so any improvement among these companies has a multiplier effect for the country. To do so, the minister described his efforts to streamline the ministry, create special economic zones, list state companies on the stock exchange, professionalize the management and bring in strategic partners for the state firms.

➤ FACT & COMMENT BY STEVE FORBES *Chairman & Editor-in-Chief, Forbes Media*

In his Fact & Comment speech, Steve Forbes, Chairman and Editor-in-Chief, Forbes Media, provided his insights on the global economy, delving into topics such as the risk of recession and rising inflation. Moderated by Rich Karlgaard, Futurist and Editor-at-Large, Forbes Media, he touched upon how inflation could be tamed by stabilizing the U.S. dollar, rather than raising interest rates and triggering an economic downturn. "You don't have to make people poor to conquer inflation but it's a mindset," said Forbes. He was also asked for his view of China, where he saw a slowdown in growth: "China's not going to be the engine it was in previous years." He ended on a positive note, noting how human ingenuity coupled with knowledge and technology has the potential to accelerate progress in society.



During the two-day conference, speakers from around the world shared insights on topics such as the global economy, technology, innovation and investment opportunities in sectors such as finance and venture capital, real estate and sports. Panels also discussed best strategies for leadership, entrepreneurship, family business, ESG and sustainability.
