

Visitor Terms & Conditions

Key Information for Event Visitors

These terms and conditions govern registrations and attendance at events (referred to as "Event(s)") organized by Syber Couture Limited ("we," "us," or "our"). By registering for or attending an Event, you ("you" or "your") agree to comply with these terms and conditions, including the Event Code of Conduct outlined below.

Event Code of Conduct

We strive to ensure that all attendees have an exceptional experience at the Event by fostering an inclusive and respectful environment. Safety, respect, and consideration are paramount.

This Code of Conduct outlines our expectations for behaviour at all event venues, including in-person and digital platforms. Any unacceptable conduct—such as aggressive behaviour, harassment, discrimination, or actions that compromise safety—will not be tolerated.

Violations of this Code of Conduct may result in immediate cessation of participation and removal from the Event. We strongly encourage all attendees to report any issues to the event team for prompt investigation and resolution.

1. Registration

1.1. Submitting your registration (either by you personally or on your behalf) is considered an offer to attend the Event, subject to acceptance by Syber Couture Limited. Registrations are confirmed either:

- In writing (e.g., via email), or
- By granting you access to the Event.

1.2. Syber Couture Limited reserves the right to reject any registration or deny entry at our sole discretion. Registrations are non-transferable and may not be sold or assigned to another person.

2. Event Modifications or Cancellations

2.1. Syber Couture Limited reserves the right to modify any aspect of the Event, including but not limited to its format, schedule, location, content, duration, or participants, without prior notice and without liability.

2.2. If the Event is postponed to a future date within 12 months, your registration will remain valid for the rescheduled Event. Refunds will not be issued unless the Event is cancelled without rescheduling.

2.3. All personal arrangements, including travel and accommodation, are your responsibility. Syber Couture Limited is not liable for any related costs or losses arising from Event changes or cancellations.

3. Entry and Conduct

3.1. Admission to the Event is at the sole discretion of Syber Couture Limited. We reserve the right to deny entry or remove individuals for reasons including, but not limited to, safety, security, or disruptive behaviour.

3.2. You must follow all instructions from Syber Couture Limited staff, venue management, and security personnel during the Event.

4. Photography, Filming, and Media Consent

4.1. By attending the Event, you agree to and consent to being photographed, filmed, or recorded. Such recordings ("Media") may include your image, voice, or likeness and may be used by Syber Couture Limited for promotional, marketing, and archival purposes.

4.2. You acknowledge that Syber Couture Limited has full ownership of all rights to the Media and waive any claims or rights to compensation or royalties regarding its use.

4.3. If you do not wish to appear in any Media, you must inform Syber Couture Limited in advance by contacting us at info@sybercouture.com or notifying staff upon arrival. While we will make reasonable efforts to accommodate such requests, we cannot guarantee the exclusion of your image from all group or public shots.

4.4. Attendees are not permitted to record, photograph, or livestream the Event without prior written approval from Syber Couture Limited. Any unauthorized materials may be confiscated or deleted.

5. Personal Data and Privacy

5.1. Any personal information you provide during registration or participation in the Event will be handled in compliance with applicable data protection laws and the Privacy Policy of Syber Couture Limited.

5.2. Your personal data may be shared with our affiliates, sponsors, or service providers to facilitate the Event or for promotional purposes.

5.3. Syber Couture Limited is not responsible for how third parties use your personal data once it has been shared via badge scanning or other methods.

6. Liability and Risk

6.1. Your attendance at the Event is at your own risk. Syber Couture Limited is not liable for any loss, damage, or injury you may experience, except where caused by gross negligence or wilful misconduct by Syber Couture Limited.

6.2. Syber Couture Limited makes no guarantees regarding the outcomes or benefits of attending the Event, including the presence of specific exhibitors, sponsors, or participants.

7. Virtual and Online Events (if applicable)

7.1. For virtual Events, you are responsible for ensuring your equipment and internet connection meet the technical requirements to access the Event platform. Syber Couture Limited is not liable for any interruptions, technical errors, or unavailability of the platform.

7.2. Access credentials (e.g., usernames and passwords) must not be shared or transferred to others. You are solely responsible for all actions taken using your access credentials.

7.3. Any materials (e.g., text, images, or videos) you upload to the Event platform are considered non-confidential, and Syber Couture Limited may use, copy, or distribute these materials as needed.
